## **Suggested Items to Accompany Application for Resident Classification**

### ***Item***

- 4 A copy of your lease or deed to the property. If neither a lease nor a deed is available, provide a statement from the owner of property indicating the terms of your occupancy including the date when it actually began.
  - 6 A copy of your Alien Registration card (green card).
  - 7 A copy of your driver's license and/or vehicle registration.
  - 8 A copy of your voter registration.
  - 9 Copies of the following to verify the date you first became a resident of Louisiana: lease or deed, utility receipts, statements from organizations you belong to that can verify your residency; verification of your Louisiana residency from a bank or credit union.
  - 10 & 16 A letter of verification sent directly to the Admissions Office- Attn: Director of Admissions from each employer for the past year.
  - 13 If yes, provide a copy of the last two returns (Federal and State). If no, and you are under the age of 24, provide a copy of your parent(s) returns or a statement that you have not been claimed on the returns of your parent(s).
  - 14 If yes, provide copies of the last two returns.
  - 17 Sign and date your statement.
- Copies of Louisiana Tax Returns are available from the Department of Revenue & Taxation, Income Tax Division, 330 N. Ardenwood, Baton Rouge, LA 70821 (phone, 225-925-4611). You may request the returns be sent to the Director of Admissions, or you may send them with your application.
  - If you have ever been classified as a resident for tuition purposes at an LSU campus, please request the Office of the Registrar at that campus to provide a statement to that effect. You may provide that statement with your application or have it sent directly to the Director of Admissions.
